RE: **My new book, *SOCIALIST COUNCILS, DEBT-BONDAGE AND SERFDOM***

Enclosed for you is a printed copy of my new book together with a CD of it saved in Microsoft Office Word (2007) and Word (97-2003). I decided to write the book following my initial shock in reading the *New Zealand Herald*, November 3, 2012, article, '*Kaipara rates rebellion grows*,' about the huge, extortionate property rates/tax increases being imposed by Kaipara District Council on ratepayers in New Zealand.

After an extensive study of Marxism/Socialism/Communism over many years – upon reading the article, it immediately became plain to me that what was happening to Kaipara citizens and ratepayers was not only unique to New Zealand – but was part of a global plot now taking place in all countries planned many years ago by the British Fabian Society.

Basically, I believe, Kaipara District Council is being insidiously used as a “test case” or “guinea pig” by the Fabian Socialist/Communist faction in the New Zealand government, in collusion with the foreign bankers, to “gradually” implement a long-term plan to disenfranchise [confiscate] all ratepayers of all privately-owned property throughout the country, and transfer that same property to foreign-controlled corporations that the bankers themselves fund, own and control.

This treacherous plan is global, and it is also connected to the “privatization” and selloff of the nation’s main strategic state assets to foreign bankers, and is happening in all countries throughout the world. It is my belief that Kaipara residents and ratepayers have been selected as the main “guinea pig” for New Zealand because the council is only a small, relatively isolated one. The fact is there are many other identical councils throughout New Zealand with similar amounts of excessive debt per capita as Kaipara and it is plain if the socialist government succeeds with Kaipara it will not be long before all other ratepayers throughout the country will GRADUALLY have their properties confiscated too.

At a higher level, what is at stake, as you will see from my book, is not only just the “freedom” to unrestrictedly own private property, houses, farms etc. free of socialist state oppression, confiscation and tyranny. What is at stake, ultimately, is actually the freedom of all private, independent thought, expression, religion, enterprise, our civil liberties etc. from a GLOBAL socialist elite dictatorship and police state in the not too distant future.

So what eventually happens to Kaipara citizens over this rates issue is vitally important for all citizens in New Zealand, as this year’s rates demands are clearly only the beginning of much bigger tax/rate oppression yet to come. We are now at the political ‘crossroads’ so to speak. Socialism only succeeds through general apathy, ignorance, and public reticence to speak up.

Often at the beginning it is very subtle and insidious and few people ever identify it as it grows in the early stages. Like cancer, if it is not eliminated in its early development, it quickly grows to become terminal, as previously was the case in Nazi Germany, and still exists today in Communist Russia and China.

Since there is currently a scarcity of really up-to-date material globally written about this vital subject, I thought I would dedicate my 2012/2013 Christmas holidays to write a short book about what I believe is subtly taking place. As what is happening ultimately will affect everybody throughout the world, (including myself and my own family), and everyone else here in New Zealand, I have written the book using New Zealand's Kaipara District Council's oppression as my primary example, for an international readership and audience in a global context.

In the end, what happens to Kaipara ratepayers and citizens is going to impact everyone else in the country sooner or later. Now is the time for all of us to set aside any old, prejudiced views and differences – to only now look at the bare facts. Now is the time to set aside any long-held Labour/Democrat or National/Republican/Tory Party views, Roman Catholic or Protestant ideologies, religious differences or whatever. Let's only look at the immutable facts, be they ever so uncomfortable, and believe me, they are. Most of the information in this book has largely been censored by the mainstream media hence the many web references throughout the book to help the reader verify the facts himself or herself. Should anyone wish to use, quote, or republish any of my extremely controversial book, in full or in part, on the internet or in any other way whatsoever, in the public interest, please do feel free to do so.

I have sent, with this letter, hard copies of the book with CDs to all individual members of the Kaipara Citizens & Ratepayers Association Inc. team as noted on their website, plus other interested parties and organizations around the world. If anyone wants to republish the book on the internet, reprint or distribute larger quantities of the book, the CD's marked "**MASTER COPY**," are best to be used for this since they are the latest re-edited copies (correcting a handful of small typist errors and a slight change to the copyright statement on page one).

The fact that the current, socialist, New Zealand Government has now had well over 6 months to rectify this outrageous oppression against Kaipara ratepayers, and has done absolutely nothing of any consequence about it, other than just sit back and insist the taxes must still be paid, and monitor how much they can get away with without a full-scale public campaign against it, shows that any acceptable resolution in the future must now come only from "We, the people."

It is clear for me at least, if nothing is substantially done to "cap" these rapidly rising property rates and taxes (there are other property taxes in the pipeline as well) to sustainable levels **GLOBALLY** for citizens in the future – not only in New Zealand – within about five years or so all citizens throughout the world will inevitably have not only all their properties confiscated, their civil liberties will have been abolished as well. So really, the choice is ours. Either we take a stand now in our own respective countries and regions, and do something about what is happening to protect our basic property rights and freedoms – or we just apathetically sit back and do nothing and within about 5 years I predict we will lose everything. It is as simple as that.
